Directions for Use

Sonalan HFP is a preemergence incorporated herbicide that controls weeds as they germinate. Sonalan HFP will not control established weeds. Refer to product label for General Use Precautions, Mixing and Application instructions.

Application Directions

Apply Sonalan HFP to established alfalfa and clover at a broadcast rate of 3 to 4 pints per acre prior to nightshade germination. Apply in at least 5 gallons of water per acre using any properly calibrated, low pressure herbicide sprayer that sprays uniformly. Use incorporation equipment that thoroughly and uniformly mixes Sonalan HFP into the top 2 to 3 inches of the soil.

Specific Use Restrictions:

- For use on fields in the production of alfalfa or clover seed. Not for use on fields producing alfalfa or clover for livestock feed. No portion of the treated field, including seed, seed screenings, hay, forage or stubble, may be used for human or animal consumption.
- All seed screenings must be disposed of in such a way that they cannot be recovered and used for food or feed.
- Do not use alfalfa or clover seed for sprouting. Processed seed must be labeled "**Not for human or animal consumption**" at the processing plant.
- Use of this product according to this labeling is considered a non-food use.
- Do not apply Sonalan HFP to soils that are wet, cloddy, or subject to prolonged periods of flooding.
- Do not apply to seedling alfalfa or clover (up to 6 true leaf stage).

Specific Use Precautions

- Where alfalfa or clover is to be rotated to another crop in the season following application of Sonalan HFP, plant only those crops to which Sonalan HFP may be applied as a preplant incorporated treatment or crop injury may occur. Do not plant sugarbeets or red beets within 13 months following an application of Sonalan HFP
